Pursuant to Penal Code section 1054 and 1054.3, you are requested to disclose to the District Attorney the following information and evidence which relate to the case described above:

(1) Names and addresses of persons (excluding the defendant) you intended to call as witnesses at the trial.

(2) Any relevant written or recorded statements of the persons described in (1) above, including reports and statements of experts made in connection with the case, and the results of physical and mental examinations, scientific tests, experiments, and comparisons which you intend to offer in evidence at trial.

(3) Any real evidence you intend to offer at the trial.

This request is a continuing request, to cover not only all such material currently in existence, but all material which comes into existence prior to the conclusion of this case.
